British Sugar TOPSOIL products are derived from prime agricultural soils, generated through the processing of sugar beet used to produce British Sugar's sugar products. Their soil products are categorised into different products according to their properties. The certificate covers two of British Sugar TOPSOIL's soil products, *L20 Landscaping* topsoil and *General Purpose Subsoil*.

L20 Landscaping is a multipurpose topsoil intended for landscaping and sports field construction projects.

*General Purpose Subsoil* is used immediately below topsoil and intended for use with products such as *L20 Landscaping* topsoil.
